When I call the Helpline, what will happen?

You will first speak with an intake worker to determine the nature of your problem and if legal aid is able to assist you. You will then talk to a legal advocate who will provide information and advice to you on your specific situation.

What information will I be asked to provide?

You will be asked to provide financial information, your name, address and telephone number, and specific information about your case. Please have any paperwork about your case (leases, denial letters, application forms, etc.) handy when you place your call. All information you provide is kept confidential.

What if someone who doesn't speak English has a legal problem?

A non-English speaking client will be asked to hold and within minutes an interpreter (available for over 150 languages) will be put on the line to translate.

Can I see an attorney in person?

Depending on your situation, you may be referred to:

- An attorney at your local NLSA office in Allegheny, Beaver, Butler, or Lawrence County.
- Another legal service or social service program that handles your particular problem.
- Legal clinics that help with issues such as custody and bankruptcy.

OR, if we can't help because of income or other restrictions, you will be directed to your local county Bar Association or Lawyer Referral Service.
