

C. MOTORCYCLE LICENSE

1. You must complete Form DL-5, take a vision test, and bring a check or money order payable to PennDOT for the appropriate fee.
2. Once you pass the motorcycle knowledge test, you will be issued a learner's permit (Class M). This permit is valid for one year, and you can schedule to take the skills test any time thereafter.
3. When you have your permit, you are only permitted to drive the motorcycle from sunrise to sunset. You cannot carry other passengers with you (instructors with a motorcycle license are allowed). Additionally, if you do not have another type of license, you can only operate the motorcycle under the supervision of a licensed motorcycle operator.
4. You must take a skills test to obtain a motorcycle license.
5. You can also obtain a motorcycle license through the Pennsylvania Motorcycle Safety Program (PAMSP). If you take and pass the course, you will be issued a motorcycle license at the end.

PENNSYLVANIA DRIVER'S LICENSES

How to Get a Driver's License, Commercial Driver's License, and Motorcycle License



AGENCY RESPONSIBLE:

The Pennsylvania Department of Transportation (PennDOT) is an administrative agency responsible for issuing and regulating driver's licenses. Visit <http://www.dmv.state.pa.us> for more information about PennDOT.

PennDOT has a Driver's Manual, Commercial Driver's Manual, and Motorcycle Manual that contains the information you need to know in order to obtain a driver's license, commercial driver's license, or motorcycle license. You can visit any PennDOT Driver's License Center to get a manual or go online to download a copy.



You must be 16 years of age or older to be able to get a driver's license

KEY POINTS

- ✓ You must be 16 years of age or older to be able to get a driver's license or motorcycle license.
- ✓ You must be 18 years of age or older to obtain a commercial driver's license.
- ✓ For all three types of licenses, you will first have to obtain a permit before being able to take a road test to get the license itself.
- ✓ You must provide proof of identity and residency to obtain a permit for all three types of licenses.

A. OBTAINING A NON-COMMERCIAL DRIVER'S LICENSE

1. If you are 16 or older, a new resident who has never been licensed, or a new resident who has been licensed in another state but whose license has been expired for longer than six months, then you must submit an application to PennDOT (Form DL-180). If you are under 18, you must also complete Form DL-180TD.
2. You must provide two forms of identification: a) Social Security card **and** b) birth certificate, certificate of U.S. citizenship, valid passport, **OR** Certificate of Naturalization.
3. You must provide two forms showing proof of residency such as utility bills, a W-2 Form, tax records, a current weapons permit, a lease agreement, or mortgage documents. If you are 16 or 17, then proof of residency is **NOT** required.



If you are under 18, you must wait six months and log 50 hours of driving **before** you can take the road test

4. Bring all of the above along with a check or money order payable to PennDOT for the appropriate fees. You will have to pass an eye screening and a knowledge test. A Learner's Permit will then be issued to you and is valid for one year. Please note that you **CANNOT** drive by yourself with a learner's permit and you must have a licensed driver who is at least 21 or licensed spouse, parent, or guardian who is at least 18 ride in the front every time you drive.
5. If you are under 18, you must wait six months and log 50 hours of driving before you can take the road test. Once this requirement is met (or if you are over 18), you must then take a road test to get a driver's license. You get three chances to pass a road test. If you do not pass the road test in three tries or your learner's permit expires before you pass, you must ask PennDOT to extend your permit by submitting Form DL-31.



Once you pass the knowledge test, you will be issued a CDL learner's permit to practice driving. The KTA and permit together are valid for one year from the date of issuance

B. COMMERCIAL DRIVER'S LICENSE (CDL)

1. If you are 18 years or older, you can get a commercial driver's license, regardless of whether you have a non-commercial license. You must complete a Form DL-31CD.
2. You must provide proof of identity and residency, bring a Pennsylvania driver's license (if you have one), and a check or money order payable to PennDOT for the appropriate fees.
3. PennDOT will issue a Knowledge Test Authorization (KTA). This **CANNOT** be used like a learner's permit to operate a vehicle; rather, it indicates the CDL classes, endorsements, and restriction removals requested by an applicant and provides you with the opportunity to take the CDL knowledge test at a Driver License Center.
4. Once you pass the knowledge test, you will be issued a CDL learner's permit to practice driving. The KTA and permit together are valid for one year from the date of issuance.
5. If your requested commercial driving privileges require a CDL road test, you must wait 15 days after obtaining your CDL learner's permit. You can schedule the road test when you get the learner's permit, but it must be scheduled more than 15 days after you get the learner's permit.
